I. INTRODUCTION

By application 2205-AVWO-45-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on May 4, 2022, Helping Hands Transportation, LLC (hereinafter "applicant") made application for one (1) additional motor vehicle in general livery service from a headquarters in Norwich under the provisions of Connecticut General Statutes, Section 13b-103(a)(4).

The applicant, holder of Livery Permit No. 3687, is currently permitted and authorized to operate four (4) motor vehicles, each having a seating capacity of less than eleven (11) passengers, in general livery service between all points in Connecticut from a headquarters in Norwich.

II. DEPARTMENT ANALYSIS

1. The applicant has submitted the proper application before the Department.
2. The applicant may apply for up to two (2) additional vehicles each calendar year without a hearing. The applicant was granted one (1) additional vehicle without a hearing on March 22, 2022 and therefore may apply for up to one (1) more additional vehicle without a hearing this calendar year.
3. Department records indicate that all the existing vehicle(s) authorized are registered and in use.
4. Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

III. CONCLUSION AND ORDER

Based on the above and pursuant to CGS Section 13b-103(a), this application is hereby approved and therefore Livery Permit Number 3687 is amended and reissued as follows:

LIVERY PERMIT NUMBER 3687 **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Helping Hands Transportation, LLC is hereby permitted and authorized to operate FIVE (5) motor vehicles, each having a seating capacity of less than eleven (11) passengers in general livery service between all points in Connecticut from a headquarters in Norwich.

The authority granted under this permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder for not less than twenty-four (24) months.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in each motor vehicle operated under this permit.
