- Chairman Eucalitto conflicts with the multimodal summit, apologies for that conflict, we have a quorum, called for the council members to introduce themselves
- Chairman Eucalitto adoption of the meeting minutes. Moved by Lt. Manzolillo and second by Jonathan Slifka. All in favor, minutes adopted
- Chairman Eucalitto next item adoption of a proposed mission statement. Was sent to
  members in advance, got great feedback from DMV which was incorporated and reshared with
  the council members. Any additional feedback? It can always be changed and we should
  update it again next year. Motion to adopt? Susan Logan motion to adopt, second by Jonathan
  Slifka. All in favor, Mission Statement adopted.
  - The Vision Zero Council (VZC) believes even one life lost in a traffic crash is unacceptable, traffic deaths are preventable, and commits to using all available tools to eliminate conditions and behaviors that lead to serious injuries and deaths. The goal of the VZC is to bring together stakeholders to introduce policies, establish partnerships, and leverage available technologies to prevent death and serious injuries. Working together, we will eliminate traffic deaths and life-altering injuries.

The VZC will build new and strengthen existing partnerships between state agencies and safety advocates who are committed to eliminating traffic crashes that cause death and serious injuries. Through policies that make roadways safer and through inclusive community engagement, VZC will achieve the goal of zero deaths from traffic fatalities.

- Chairman Eucalitto discusses overview of the Infrastructure Investment and Jobs Act (IIJA). Penalty coming for allowing open containers in motor vehicles. A portion of our construction funds are moved to prevention and education.
- Vision Zero Council Website, led by Aaron. Set up under the DOT website, showed how to find it from the main DOT page. The website is still in its early stages. Thanks to our IT staff and front

- office staff. Showed many of the features offered by the website. Showed the link to the SOTS calendar. Showed the form to apply to be a part of the subcommittees. encouraged people to fill out the form for Aaron and Diana to review.

- Chairman Eucalitto discussion about subcommittees. Engineering, Enforcement, Education,
  Emergency Medical Services and Equity. Want members of the council or members of the
  council's team or agency to participate. Please fine at least one person from your agency to be
  a member of a subcommittee, they would be valuable subject matter experts to have on the
  subcommittees. Also want to encourage interested safety stakeholders and members of the
  public to participate.
- Susan Logan should we as council members pick a subcommittee to sit on? Garrett Eucalitto –
  you don't have to but someone from your agency should be. You can be but I wouldn't suggest
  being on all of them.
- Jonathan Slifka it would be helpful if you could give us a description of what each of the subcommittees is going to be tasked with so we can best inform people from our agencies what we are asking of them. Garrett yes we can do that but I want to leave it up to the subcommittees to be able to define what they want it to be. But we can provide what we believe what they will be focusing on.
- Susan Equity fits under each of these, I'm not sure it should be separate. Garrett you are right but we were thinking it should stand alone too, I expect overlap.
- Garrett on the DOT side as names are submitted we will begin to pull them together, Aaron
  and Diana can't provide support for all of them, we will look to lean on some of the other staff
  from our agencies who are participating on each of these. We will scope out when we can begin
  to hold these meetings and let you know.
- Chairman Eucalitto next item Interagency Policy, the annual policy that we must submit by February 1, 2022. This first one won't be as robust if we had a full year to work on it. We will submit something to the General Assembly. Aaron will work on providing a broad outline based on what is being done across the country. Broad outline will be shared from DOT, council members will comment and add to the outline to create the draft policy. The draft will be complete for public review and comment early in January (posted on VZC website). We will incorporate comments and then final discuss and adoption of the policy at the 1/19/2022 meeting.
- Aaron walking through the Interagency Policy and research he did, looking at other places
  action plans. Vision Zero network. DOT will provide the start of a policy, this policy will be
  reviewed annually. Where we are and where we think we are going to go.
- Chairman Eucalitto Council keep your eyes on your email for the materials about this Interagency Policy. And It will be posted on our website for public comment. We will get out a synopsis of the subcommittees. Council members please get us individuals from your agencies for the subcommittees.
- Susan Logan do we need to decide the different modes of transportation for how to break out
  the criteria from the IJA? Garrett no NHTSA will make those recommendations a few years
  down the road.
