I. INTRODUCTION

It was brought to the Department's attention on July 31, 2020 that the last final decision written for Permit 2240, application 1505-AVWO-54-L, was missing previous authorities. This final decision includes all previous authorities.

By application 1505-AVWO-54-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on May 8, 2015, Town & Country Transportation Co (hereinafter "applicant") made application for two (2) additional motor vehicles in general livery service from a headquarters in New Britain under the provisions of Connecticut General Statutes, Section 13b-103(a)(4).

The applicant, holder of Livery Permit No. 2240, is currently permitted and authorized to operate:

1. ONE (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in General Livery service between all points in Connecticut from a headquarters in New Britain.
2. Vehicles of the Bus type, with a passenger seating capacity of more than ten (10) passengers, in General Livery service between all points in Connecticut from a headquarters in New Britain.

Town & Country Transportation Co is further permitted and authorized to operate motor vehicles for the transportation of passengers in special and charter operations in interstate commerce under such authorization as issued or amended by the Federal Highway Administration (formerly the Interstate Commerce Commission) in the issuance of Certificate No. MC-167514.

Town & Country Transportation Co is further authorized to operate TWO (2) motor vehicles, each having a seating capacity of less than eleven (11) passengers, for the provision of transportation for hire by virtue of a contract(s) with or lower tier contract(s) for Federal, State or Municipal agencies from a headquarters in New Britain.

II. DEPARTMENT ANALYSIS

1. The applicant has submitted the proper application before the Department.
2. It has been at least one calendar year since the applicant last applied for additional vehicle(s).
3. Department records indicate that all the existing vehicle(s) authorized are registered and in use.
4. Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

III. CONCLUSION AND ORDER

Based on the above and pursuant to CGS Section 13b-103(a), this application is hereby approved and therefore Livery Permit Number 2240 is amended and reissued as follows:

LIVERY PERMIT NUMBER 2240
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Town & Country Transportation Co is hereby permitted and authorized to operate:

1. ONE (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in General Livery service between all points in Connecticut from a headquarters in New Britain.
2. Vehicles of the Bus type, with a passenger seating capacity of more than ten (10) passengers, in General Livery service between all points in Connecticut from a headquarters in New Britain.

Town & Country Transportation Co is further permitted and authorized to operate motor vehicles for the transportation of passengers in special and charter operations in interstate commerce under such authorization as issued or amended by the Federal Highway Administration (formerly the Interstate Commerce Commission) in the issuance of Certificate No. MC-167514.

**DURATIONAL LIVERY SERVICE UNDER CONTRACT(S)
WITH OR LOWER TIER CONTRACT(S) FOR
FEDERAL, STATE OR MUNICIPAL AGENCIES
DOCKET NO. 9708-GOV-72-L – GRANTED ON AUGUST 18, 1997**

Town & Country Transportation Co is further authorized to operate TWO (2) motor vehicles, each having a seating capacity of less than eleven (11) passengers, for the provision of transportation for hire by virtue of a contract(s) with or lower tier contract(s) for Federal, State or Municipal agencies from a headquarters in New Britain.

RESTRICTIONS:

The authority for the two (2) motor vehicles granted in Docket No. 9708-GOV-72-L shall be durational in nature and shall exist only for the period of time that the permit holder has a current and continuing contract(s) with or lower tier contract(s) in effect for Federal, State, or Municipal agencies.

The permit holder shall notify the Department of any termination of its contract(s) with or lower tier contract(s) for Federal, State or Municipal agencies or the cessation of the active provision of service thereunder. The permit holder shall file with the Department on an annual basis, upon registration or re-registration of the motor vehicles authorized in this decision, a current, executed copy of the extension of said contract. Failure to file an extension of the contract, or a new executed contract shall void the authority for the vehicles authorized pursuant to this contract.

This permit is not transferable and shall remain in effect until revoked by the Department or until the contract under which this authority is granted has expired. Failure of the permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State statutes and/or rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke said permit.

The authority granted under this permit may not be sold or transferred until it has been operational, i.e. a vehicle registered with livery plates thereunder for not less than twenty-four (24) months.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in each motor vehicle operated under this permit.
