**REGISTRATION OF A FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION**  
**INTERSTATE CHARTER BUS AUTHORITY**

INTRODUCTION

By application 2305-I-74-B filed with the Connecticut Department of Transportation (hereinafter “Department”) on May 5, 2023, DD3 Coach LLC (hereinafter “applicant”) of 542 Ravenelle Road, North Grosvenordale, Connecticut seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in Certificate No. MC-01056109-C issued on September 24, 2021.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Sections 13b-88, 13b-89, and 13b-94a, and Interstate Charter Bus Permit No. 586 is issued to DD3 Coach LLC in the following form:

**BUS PERMIT NO. 586**  
**FOR THE OPERATION OF MOTOR VEHICLES IN INTERSTATE CHARTER BUS**  
**OPERATIONS**

DD3 Coach LLC is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter bus operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate No. MC-01056109-C.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State Statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke the permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within sixty (30) days of the date on this decision.**

Memorandum of the Permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
