REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION
AUTHORITY

By application 2307-I-103-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on July 11, 2023, BDL Livery LLC dba Jaguar Limo (hereinafter "applicant"), seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-00135240-C, issued on October 3, 2022. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

BDL Livery LLC dba Jaguar Limo is currently permitted and authorized to operate NINE (9) motor vehicles, each having a seating capacity of ten (10) passengers or less in general livery service between all points in Connecticut from a headquarters in Windsor Locks.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3454 is amended and reissued to BDL Livery LLC dba Jaguar Limo in the following form:

LIVERY PERMIT NUMBER 3454
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

BDL Livery LLC dba Jaguar Limo is permitted and authorized to operate NINE (9) motor vehicles, each having a seating capacity of ten (10) passengers or less in general livery service between all points in Connecticut from a headquarters in Windsor Locks.

BDL Livery LLC dba Jaguar Limo is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-00135240-C.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**
