REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION
AUTHORITY

By application 2307-I-104-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on July 11, 2023, Trusted Limo LLC (hereinafter "applicant"), seeks approval to register their Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-1479988-C, issued on October 27, 2022. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

The applicant, holder of Livery Permit No. 3655, is currently authorized to operate one (1) motor vehicle, having a passenger seating capacity of eleven (11) passengers or less in general livery service between all point in Connecticut from a headquarters in West Hartford.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3655 is amended and re-issued to Trusted Limo, LLC in the following form:

LIVERY PERMIT NUMBER 3655
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Trusted Limo LLC is hereby permitted and authorized, in accordance with and under the provisions of the General Statutes, as amended, to operate:

1. One (1) motor vehicle having a passenger seating capacity of eleven (11) adults or less, in general livery service between all points in Connecticut from a headquarters in West Hartford.

Furthermore, Trusted Limo, LLC is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-1479988-C.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**
