**INTRODUCTION**

By application filed on December 13, 2023, with the Department of Transportation (hereinafter "Department"), United Rides, LLC (hereinafter "applicant") has re-entitled its authority to Yudy Alexandra Cubillos Perdomo. Therefore, Livery Permit Number 3730 is amended and re-issued as follows:

**LIVERY PERMIT NUMBER 3730**  
**FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Yudy Alexandra Cubillos Perdomo is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate one (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in general livery service between all points in Connecticut from a headquarters in Stamford.

Yudy Alexandra Cubillos Perdomo is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-1296419-C.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within ninety (90) days of the date of this decision.**

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicle operated hereunder.
