Data Evaluation and Analysis Grant Funded Programs

Kerri Raissian, Chair

8 funded awardees announced on November 16, 2023 so no evaluation has been done yet. Primary, secondary and tertiary prevention is covered in all programs.

Commissioner Juthani wanted to clarify that CTVDRS stands for Connecticut Violent Death Reporting System.

Kerri Raissian: We believe that evaluation services are 2 pronged.

- 1. Improve service delivery.
- 2. Help make us more competitive.

Pina Violano: Can we add a 4th short term objective? Youth voices are heard!

Jackie asked how people are appointed to Sub-Committees?

Chief Jacobson commented on how they are spreading their work around the state and have listening session scattered throughout the State.
