



On to his next adventure......

Chris Prokop is leaving the Yale Regional Lead Treatment Center and the CT Children's Healthy Homes Program to begin a new adventure with the Yale Nurturing Families Network Home Visiting Program.

Chris has worked in lead poisoning prevention for over 15 years. During his tenure, he has assisted hundreds of families, clinicians and local health department staff in treating and preventing lead poisoning.

We want to wish Chris a "Bon Voyage" and best of luck in his new role. He will be missed by all.



The Lead, Radon and Healthy Homes Program (LR&HHP) has been working with HUD in response to an amendment to the HUD Lead Safe Housing Rule. The amendment requires Public Housing Authorities (PHAs) to complete a lead inspec-

tion in subsidized funding housing units, when a child less than 6 years of age resides, and has a blood lead level $\geq 5 \mu g/dL$.

The LR&HHP will be emailing data matches to PHAs next week and sharing the same data with the respective local health departments (LHDs).

Next steps:

- PHAs will confirm that the poisoned child resides in the matched unit
- PHAs are then required to hire a licensed lead consultant to conduct a comprehensive lead inspection
- If lead hazards are identified during the inspection, this will be reported to the LHD and the LR&HHP - this will trigger a non-EBLL case (LHDs will be required to proceed under 19a-111 regulations
