VOTE 1: LINE-ITEM ADJUSTMENT TO A PREVIOUSLY VOTED WIOA ALLOCATION

Background: For PY23 Annual WIOA Allocations, a portion of the Governor's Reserve was allocated, in equal distribution, to each Local Workforce Development Boards. During operationalization of the allocation, the Boards would like to expand the allowable uses to include funding that would also directly support Participants in their region. *A vote must be taken to expand this line-item, see language in red below.*

PY23 Allocations: Previously Voted & Approved

Proposed: WIOA Activities/Support - \$883,003

***Specific allocations TBD**

- 1. Workforce Systems Data Improvements:** Continued evaluation and investment in the improvement of access to state workforce development resources and cross agency data collection, management, and reporting tools in CTHires, expansion of CareerConneCT portal, and other possible complementary tools.
- 2. Career Pathways Activities:** Expansion and system innovation of work-based learning, summer youth employment, pre-apprenticeship, and apprenticeship in ways that explicitly align students and employers.
- 3. Workforce Development Boards Improvements:** Equal funding to the WDBs for American Job Center customer experience improvements, including, but not limited to, integrated IT systems. *Funding shall also be available for participant experience and training.*

Vice-Chair Vallieres calls the meeting to order at 4:08pm.

- Provided opening remarks, welcoming new Council members Nitin Kumar of Tata Consultancy Services and Maurie McInnis, new president of Yale University. Gives updates on WIOA plan.
- Discussed the Program Year 2024 allocation of formula funds for WIOA, as determined by state factors and used to fund workforce boards Title I activities.

Vice-Chair Vallieres reviews the items to be voted on and calls the committee to vote at 4:17pm.

- Vice-Chair Vallieres discusses the WIOA Unified State Plan being conditionally approved and available on the website at portal.ct.gov/gwc/wioa. The local plans, including executive summaries, are also



accessible. An electronic vote to the Executive Committee on these plans is forthcoming.

Vice-Chair Vallieres reviews Strategic Plan's overview, goals, and key indicators at 4:30pm

- Workforce System Challenges and Strategic Plan Overview. Discussed the new strategic plan's focus on fewer but more impactful initiatives than the previous plan. The plan aims to make Connecticut the most productive workforce system in the country by filling critical shortage areas and aligning education with business needs. Key focus areas include manufacturing, technology, healthcare, clean energy, infrastructure, and information technology. The plan includes significant investments in ARPA dollars to scale best practices in workforce development.
- Goals and Indicators: Goal one is filling critical shortage areas with globally competitive talent. With indicators ensuring every student and job seeker has a job upon completion of their program, aligned with business needs. Goal two is providing opportunities and access for underserved communities. Indicators include increased: wages, employment, industry-recognized credential attainment, and postsecondary degree attainments aligned with industry needs in these populations. Goal three to create a data-driven Workforce system. Indicators for goal three to include access to real-time data for effective decision-making and reporting and providing programmatic outcomes to students and job seekers to enable informed decisions on education and training.
- Alignment and Best practices in Workforce Development. Highlighted the need to align workforce programs and funding streams to build on existing efforts and ensure all are working toward the same goal. Plan includes two foundational pillars and three strategic pillars, based on lessons learned from the previous plan. First foundational pillar is diversity, equity, access, and inclusion with a focus on removing unique barriers for underserved communities. Second foundational pillar is data-driven decision-making, ensuring all efforts are grounded in accurate data.
- Strategic Pillars and Achievements: Industry Leadership is a strategic pillar with the establishment of regional sector partnerships to engage industry partners. Education and Sector-based training are separated into two pillars, focusing on enhancing dual and concurrent enrollment programs. Sector-based training aims to provide industry-recognized credentials to upskill individuals and move them into career pathways.

Governor Ned Lamont remarks at 4:48pm

- Governor Lamont emphasized the importance of workforce development as a strategic advantage for Connecticut and benefits of working to align different entities to ensure seamless workforce development efforts. Highlighted workforce development as a priority over the past six years. Despite a national labor shortage, Connecticut is experiencing a rebound in labor participation rates, among the highest in the U.S. Discussed initiatives like partnerships with community colleges, the importance of integrating workforce training from K-12 through higher education and increasing collaboration with businesses to better align training with job needs. Also spoke to specific programs aimed at addressing skill shortages in critical sectors like healthcare and manufacturing, and incentives to encourage hiring and support for employee childcare needs.

Vice-Chair Vallieres adjourns meeting for Breakout discussions.
