Governor Lamont signed the following legislation of the 2025 Regular Session on June 10:

SB 1239 PA 25-61	AN ACT CONCERNING THE FALLEN HERO FUND AND PROVIDING HEALTH INSURANCE COVERAGE TO SURVIVORS OF FIRST RESPONDERS WHO ARE KILLED IN THE LINE OF DUTY.
SB 1455 PA 25-62	AN ACT CONCERNING CERTAIN BUSINESS REPORTING REQUIREMENTS.

As of this date, the governor has signed 64 bills and signed and line-item vetoed 2 bills of the 2025 Regular Session.
