Governor Lamont signed the following legislation of the 2025 Regular Session on June 30:

SB 1562 SA 25-15	AN ACT CHANGING THE AUTHORIZED USE OF A PARCEL OF STATE LAND PREVIOUSLY CONVEYED TO THE TOWN OF NEWTOWN.
HB 7082 PA 25-66	AN ACT CONCERNING VARIOUS REVISIONS TO THE MONEY TRANSMISSION STATUTES, STATE PAYMENTS AND INVESTMENTS IN VIRTUAL CURRENCY AND MINORS' MONEY SHARING APPLICATION ACCOUNTS.
HB 6438 PA 25-95	AN ACT CONCERNING ASSORTED PROPOSALS TO RECOGNIZE AND HONOR THE MILITARY SERVICE OF MEMBERS OF THE ARMED FORCES AND VETERANS IN CONNECTICUT.
HB 7041 PA 25-114	AN ACT CONCERNING THE COMPOSITION OF THE JUDICIAL SELECTION COMMISSION AND DECISIONS RENDERED BY SAID COMMISSION.
SB 1250 PA 25-119	AN ACT IMPLEMENTING THE GOVERNOR'S BUDGET RECOMMENDATIONS FOR HIGHER EDUCATION.
SB 1266 PA 25-121	AN ACT REQUIRING THE POSTING OF FAIR RENT COMMISSION BYLAWS AND THAT THE HEARINGS OF SUCH COMMISSIONS BE OPEN TO THE PUBLIC.
SB 1520 PA 25-124	AN ACT CONCERNING AN AMENDMENT TO THE FREEDOM OF INFORMATION ACT CONCERNING EDUCATION RECORDS.
HB 6075 PA 25-128	AN ACT CONCERNING INSTRUCTORS FOR AN AIRFRAME AND POWERPLANT CERTIFICATE PROGRAM.
HB 6833 PA 25-133	AN ACT CONCERNING THE LEGISLATIVE COMMISSIONERS' RECOMMENDATIONS FOR TECHNICAL REVISIONS TO STATUTES RELATING TO PLANNING AND DEVELOPMENT.
HB 6849 PA 25-134	AN ACT CONCERNING THE LEGISLATIVE COMMISSIONERS' RECOMMENDATIONS FOR MINOR AND TECHNICAL REVISIONS TO THE GOVERNMENT ADMINISTRATION AND ELECTIONS STATUTES.
HB 7064 PA 25-136	AN ACT CONCERNING REVISIONS TO THE VALIDATING ACT.

HB 6921 PA 25-143	AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE OFFICE OF EARLY CHILDHOOD, DEPARTMENT OF EDUCATION AND THE TECHNICAL EDUCATION AND CAREER SYSTEM AND CONCERNING THE ADMINISTRATION OF EPINEPHRINE AND GLUCAGON.
HB 7027 PA 25-146	AN ACT CONCERNING THE USE OF CONDOMINIUM DEPOSITS FOR CONSTRUCTION AND DEVELOPMENT, ACCOUNTING OF RENTAL CHARGES AND A WORKING GROUP TO DEVELOP A UNIFORM STATUTORY DEFINITION OF "AFFORDABLE HOUSING".
HB 6859 PA 25-157	AN ACT CONCERNING THE DEPARTMENT OF EMERGENCY SERVICES AND PUBLIC PROTECTION'S RECOMMENDATIONS REGARDING FIREARM INFORMATION, SECURITY OFFICERS, FIREARM TRANSFERS AND SCHOOL SECURITY GRANTS AND THE FIRE MARSHAL TRAINING COUNCIL, THE COMMISSION ON FIRE PREVENTION AND CONTROL AND THE CODES AND STANDARDS COMMITTEE.
HB 7131 PA 25-158	AN ACT CONCERNING FINANCIAL AID FOR STUDENTS IN PARAMEDIC CERTIFICATE PROGRAMS.
HB 7200 PA 25-160	AN ACT CONCERNING BLEEDING CONTROL TRAINING AND KITS.
SB 1541 PA 25-161	AN ACT CONCERNING THE OFFICE OF THE CORRECTION OMBUDS, DISCLOSURE OF DISCIPLINARY MATTERS OR ALLEGED MISCONDUCT BY A DEPARTMENT OF CORRECTION EMPLOYEE, USE OF FORCE AND BODY CAMERAS IN CORRECTIONAL FACILITIES AND CRIMINAL HISTORY RECORDS.
HB 7287 PA 25-168	AN ACT CONCERNING THE STATE BUDGET FOR THE BIENNIUM ENDING JUNE 30, 2027, AND MAKING APPROPRIATIONS THEREFOR, AND PROVISIONS RELATED TO REVENUE AND OTHER ITEMS IMPLEMENTING THE STATE BUDGET.
HB 7288 PA 25-174	AN ACT AUTHORIZING AND ADJUSTING BONDS OF THE STATE AND CONCERNING GRANT PROGRAMS, STATE GRANT COMMITMENTS FOR SCHOOL BUILDING PROJECTS, REVISIONS TO THE SCHOOL BUILDING PROJECTS STATUTES AND VARIOUS PROVISIONS REVISING AND IMPLEMENTING THE BUDGET FOR THE BIENNIUM ENDING JUNE 30, 2027.

As of this date, the governor has signed 140 bills; signed and line-item vetoed 2 bills; and vetoed 2 bills of the 2025 Regular Session.
