#### **II. Presentation: Employer Value Proposition (EVP), Samantha Rivera, DAS Talent Solutions**

Samantha Rivera of DAS Talent Solutions, presented on the Employer Value Proposition (EVP), a new resource on the state's website. The EVP is featured on the Online Employment Center, a page to view and apply to all positions within the executive branch. An Employer Value Proposition is the core promise an organization makes to their employees that captures the essence of what's in it for the employee, such as benefits, culture, and the state's commitment as an employer. There are four pillars to the EVP: meaningful work, limitless opportunities, work life balance, and diverse and fresh perspectives.

Rocky Young, of DAS Talent Solutions, provided an overview of another new resource on the Online Employment Center, the Applicant Reference Library.
