This communication is being sent to all key contacts at provider organizations enrolled in the CT Vaccine Program (CVP). Please feel free to share it with others in your organization who may benefit from the update. Note that all our communications are archived on our web site [here](#).

Dear CVP providers,

The Centers for Disease Control and Prevention (CDC) recently notified the CT Immunization Program that the state will receive an additional allocation of nirsevimab on **Monday, October 21st**. All nirsevimab orders should continue to be placed via this [link](#) by noon on the allocation date.

Below is the updated anticipated allocation schedule provided by CDC. Please note that dates and allocation amounts are subject to change at any time. All orders will be placed by the immunization program the day after the order submission date. If you place an order and you do not receive any doses for that allocation, please place a new order before the next date. DPH will not take previously submitted orders into account when allocating new doses.

A few additional reminders:

- Please order based on your patient population based on current [Advisory Committee on Immunization Practices recommendations](#):

50mg vials contain a single dose for infants <5kg;

100mg vials contain a single dose for infants ≥5 kg.

- Once allocation is determined, the email provided with the RSV order request will be notified of the number of doses your clinic should expect to receive. Please ensure the email provided is checked regularly.
- If you received nirsevimab through the CVP and don't anticipate being able to administer all of the vials received, please submit a [help desk ticket](#) to receive a list of providers who may be willing to accept the transfer.
- Please take note of the allocation amounts listed above. In the coming weeks we anticipate receiving larger allocations of the 50mg doses. Please continue placing orders based on what you can utilize for 2 weeks until we are able to fulfill all provider orders. The program will continue to fulfill requests to the best of our ability.
