D E C I S I O N A N D O R D E R

Pursuant to the foregoing Opinion, the Council hereby directs that a certificate of environmental compatibility and public need as required by section 16-50k of the General Statutes of Connecticut, revisions of 1958, revised to 1983, as amended, shall be issued to United Cable Television Corporation of Eastern Connecticut, for the erection of a community antenna television head-end tower and earth station at 200 Boston Turnpike, Bolton, Connecticut, as specified in the Council's record on this matter, subject to the following conditions:

1. The head-end tower shall be no taller or wider than necessary to provide the proposed service and in no event shall it exceed 63 feet in height as proposed in the application;
2. A screened fence not lower than eight feet shall surround the tower and earth station facilities;
3. No associated equipment other than that referred to in Council findings number 19 and 21 shall be added to the tower or earth station without prior notification to the Council, even if, in the certificate holder's opinion, no Council action is required;
4. Following the installation and initiation of operation of CATV equipment on the head-end tower, power densities shall be measured to confirm the predicted levels cited in Council finding number 42 and reported to the Council with a qualified engineer's certification;

5. The applicant shall leave as many trees standing on the property as possible in order to screen the view of the tower from nearby roads;
6. The applicant shall submit a development and management plan pursuant to sections 16-50j-75 through 16-50j-77 of the regulations of state agencies that irrelevant items in section 16-50j-76 need only be identified as such;
7. The facility construction shall be conducted in accordance with all applicable federal, state, and municipal laws and regulations; and
8. This decision and order shall be void if all construction authorized is not completed by July 12, 1985 unless otherwise authorized by the Council as an amendment to the certificate.

We hereby direct, pursuant to section 16-50p(c) of the General Statutes, that a copy of the opinion and decision and order be served on each person listed below. A notice of the issuance shall be published in the Hartford Courant and the Journal Inquirer.
