RE: Docket 272, Middletown-Norwalk Transmission Project Development and Management Plan- Crossings of Watercourses and Railroads in Segments 3, 4a and 4b of the Middletown-Norwalk Project

Dear Chairman Caruso:

In accordance with the Connecticut Siting Council (Council) Decision and Order for Docket 272, dated April 7, 2005, the Connecticut Light and Power Company (CL&P) hereby re-submits the Development and Management (D&M) Plan for the Underground Cable Crossings of Watercourses and Railroads along the Underground Portion of the Middletown-Norwalk Project. The Plan was developed pursuant to Sections 16-50j-60 through 16-50j-62 of the Regulations of Connecticut State Agencies, "Requirements for a Right-of-way Development and Management Plan." The Watercourse and Railroad Crossings D&M Plan includes the installation of 345-kV XLPE underground transmission lines at five (5) watercourse crossings and two (2) railroad crossings in Milford, Stratford, Bridgeport, Fairfield, and Westport. Enclosed are the original, fifteen (15) copies of Volume 1, five (5) copies of Volume 2, fifteen (15) copies of Volume 3; and an electronic CD-ROM containing the above referenced items.

Please note that this submission supersedes the September 8, 2006 submission of the Underground Cable Crossings of Watercourses and Railroads D&M Plan. Three of the watercourses crossing methods have changed since the previous submission, including Ash Creek, Mill River (Southport Harbor) and Sasco Creek. To aid in the Council's review of Volume 1, a single tracked-changes version is included.
