Dear Mr. Barbagallo:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on January 28, 2016.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

The construction drawings propose the installation of two cables and one fiber trunk that are not included in the structural evaluation.

Please submit revised construction drawings and/or a revised structural evaluation for this filing.

Therefore, the notice of intent to modify an existing telecommunications facility is incomplete at this time. The Council recommends that AT&T provide information to clarify or fulfill the deficiencies noted above on or before February 23, 2016.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
