Dear Mr. Wilson:

The Connecticut Siting Council (Council) hereby denies your request to modify the above-referenced existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

This exempt modification request was submitted to the Council on July 23, 2018. Council staff reviewed this request for completeness and had identified a deficiency that was more fully described in a notice of incompleteness letter to the requesting entity dated July 25, 2018 and recommended that Empire Telecom provide evidence that notice was provided to the municipal planning and zoning department, a mount analysis for the proposed equipment that is stamped and signed by a professional engineer duly licensed in the State of Connecticut and an updated Structural Analysis Report accounting for any required antenna mount modifications on or before August 22, 2018. To date, the Council has not received the requested proof of notice or Mount Structural Analysis Report.

Thus, the proposed modification is not in compliance with the exemption criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies.

Dear Mr. Wilson:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on July 23, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the filing due to lack of notice to the municipal Planning and Zoning Department. The Council's January 17, 2017 memorandum is attached for your convenience. Also, the Construction Drawing sheet C-2 drawing 2 prepared by Centek Engineering Inc., last revised on April 30, 2018 shows a "proposed replacement antenna platform," which is not indicated in the Structural Analysis report by Paul J. Ford and Company dated November 8, 2017.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Empire Telecom provide evidence that notice was provided to the municipal planning and zoning department, a mount analysis for the proposed equipment that is stamped and signed by a professional engineer duly licensed in the State of Connecticut and an updated Structural Analysis Report accounting for any required antenna mount modifications on or before August 22, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to August 22, 2018.

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
