RE: **EM-AT&T-132-190430** – AT&T notice of intent to modify an existing telecommunications facility located at 300 Governors Highway, South Windsor, Connecticut.

Dear Ms. Zsamba:

The Connecticut Siting Council (Council) hereby denies your request to modify the above-referenced existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

This exempt modification request was submitted to the Council on April 30, 2019. Council staff reviewed this request for completeness and had identified deficiencies (attached) that were more fully described in a notice of incompleteness letter to the requesting entity dated May 2, 2019 and recommended that Crown Castle provide a Construction Drawing that is stamped and signed by a Professional Engineer registered in the State of Connecticut, and a Structural Analysis Report that accounts for the proposed antenna mount modifications, on or before May 31, 2019.

The Council received a request for an extension of time in an email on May 17, 2019 and granted a one-month extension of time to submit the required documentation by July 1, 2019 (attached). To date, the Council has not received the requested Construction Drawings and Structural Analysis Report.

Thus, the proposed modification is not in compliance with the exemption criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies.

Dear Ms. Zsamba:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on April 30, 2019.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the Construction Drawings (CD) last revised April 29, 2019 and prepared by Jacobs Engineering Group, Inc. The CD is stamped but not signed by a professional engineer registered in the State of Connecticut. Also, the Structural Analysis Report (SA) dated April 22, 2019 and prepared by Paul J. Ford and Company does not account for the proposed antenna mount modifications as indicated in the CD and the Mount Modification Report (MA) dated February 11, 2019 and prepared by Infingy.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Crown Castle provide a CD that is stamped and signed by a professional engineer registered in the State of Connecticut, and a SA that accounts for the proposed antenna mount modifications referenced above, on or before May 31, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 31, 2019. **Please provide an electronic version and one hard copy of the CD and SA for the incomplete request to be rendered complete and processed.**

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
