Dear Mr. Noel:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on November 21, 2019.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified the following deficiencies:

1. The mailing receipts/tracking numbers provided with the request as proof of notice do not indicate the names of the recipients of such notice; and
2. The email showing correspondence with the Town of Thompson references a Council decision for an exempt modification request. However, this facility was originally approved by the Town.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Smartlink, LLC provide mailing receipts that clearly indicate the names of the recipients and documentation showing the original facility approval with conditions, if any, or correspondence with the Town stating that there are no records of the original facility approval, on or before January 3, 2020. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to January 3, 2020. **Please provide an electronic version and one hard copy of the requested information for the incomplete exempt modification request to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.**

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
