## **DIRECTIONS – PETITION 1184**

### **TO FIELD REVIEW - 401 Lopus Road, Beacon Falls Town Garage, 2:00 pm**

#### **Via Interstate 84 (Waterbury)**

Follow I-84 to Route 8 South.

Follow Route 8 south to Exit 24

At end of Exit 24 ramp, turn right on Main Street.

Take next right onto Depot Street and cross bridge.

At T intersection at stop sign, turn right onto Railroad Avenue and follow over the railroad.

At T intersection, turn left onto Lopus Road and follow uphill.

Continue on Lopus Road over the highway, bearing left at a T intersection.

Travel 0.5 miles and turn left into driveway after Town Garage building and cell tower.

#### **Via Route 8 Heading North (from Bridgeport)**

Follow Route 8 north to Exit 23.

At end of Exit 23 ramp, turn left onto Route 42 west.

Follow Route 42 west over the Naugatuck River.

After bridge crossing, take next right onto Old Pines Bridge Road.

The road turns into Lopus Road – turn right into driveway after the sewage plant and before the cell tower.

#### **From New Haven/Milford**

Follow I-95 to Exit 38 - Merritt Parkway Connector

Follow Merritt Parkway south to Exit 52, Route 8.

Follow Route 8 north.

See directions "Route 8 Heading North" above.

### **TO HEARING: Beacon Falls Firehouse, 35 North Main Street, Beacon Falls, 3:00 pm**

#### **From Site**

Turn left onto Lopus Road, following the road to Route 42 at stop sign.

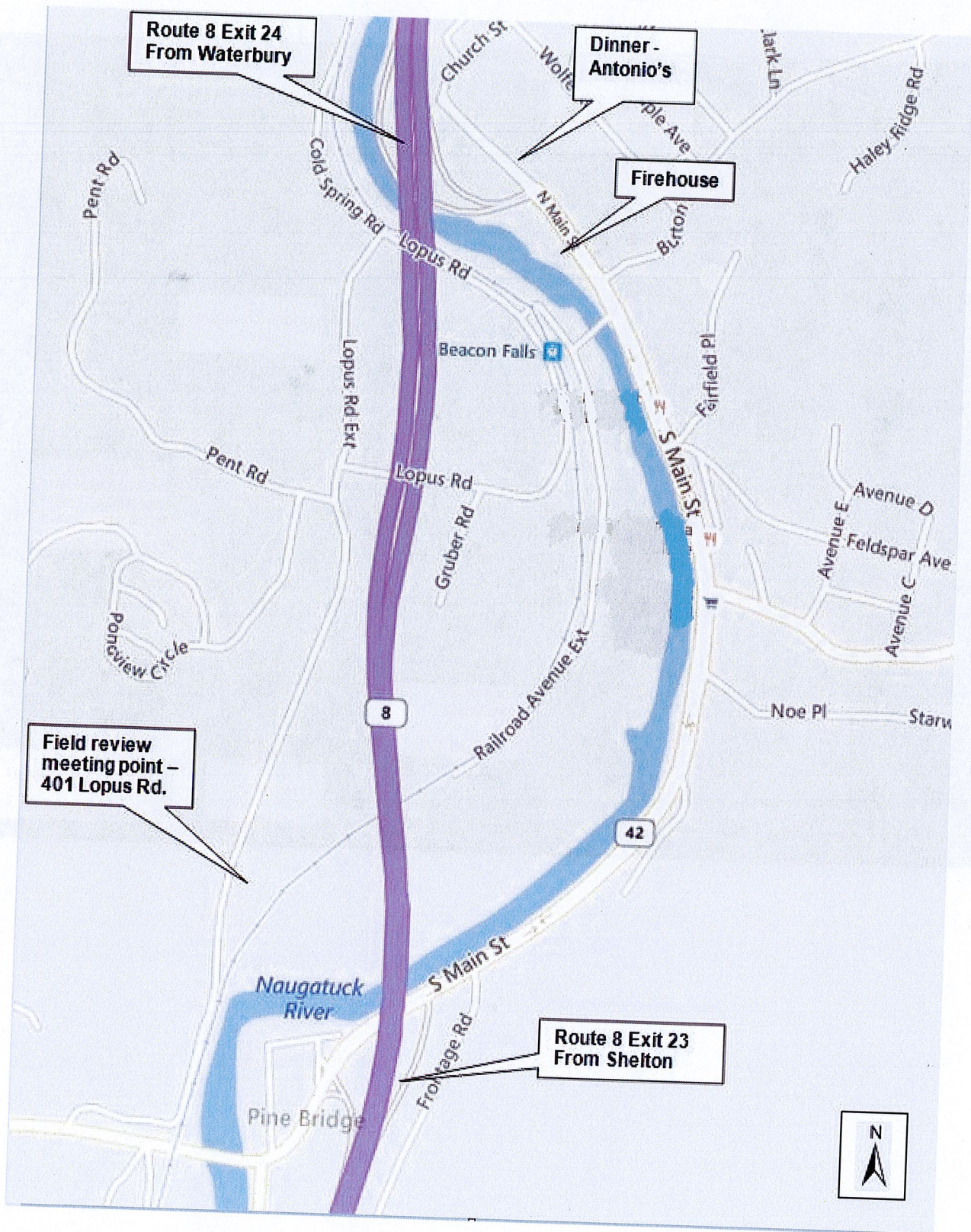
Turn left onto Route 42 east.

Follow Route 42 east for 1.6 miles into Beacon Falls.

After brick factory apartment complex and traffic light, turn left into Firehouse parking lot – use opening in traffic median to access the parking lot.
