Pursuant to Section 16-50j-40 of the regulations Connecticut State Agencies, "Prior to submitting a petition for a declaratory ruling to the Council, the petitioner shall, where applicable, provide notice to each person other than the petitioner appearing as the record as an owner of the property which abuts the proposed primary or alternative sites of the proposed facility, each person appearing of record as an owner of the property or properties on which the primary or alternative proposed facility is located , and the appropriate municipal officials and government agencies. **Proof of such notice shall be submitted with the petition for declaratory ruling. The council recommends that the petitioner provide proof of service of a copy of the petition for declaratory ruling on the Town of Stratford on or before November 18, 2016.**
