**RE: PETITION NO. 1279** - Bloom Energy Corporation, as an agent for The TJX Companies Inc., petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, operation and maintenance of a Customer-Side 500-Kilowatt Fuel Cell Facility to be located at the TJX building, 1415 Blue Hills Avenue, Bloomfield, Connecticut.

Dear Mr. Adams:

The Connecticut Siting Council (Council) received the petition for the above-referenced facility on December 13, 2016.

According to Section 16-50j-39a of the Regulations of Connecticut State Agencies, "no declaratory ruling shall be issued to any person until a complete petition containing all information relevant by the Council has been filed." Staff has reviewed this petition for completeness and has identified the following deficiencies in the filing:

1. notice to the appropriate municipal officials of the Town of Windsor, which is within 2,500 feet of the proposed facility;
2. notice to the Bloomfield Inland Wetland and Watercourse Commission; and
3. notice to owners of property identified as parcel nos. 8124 and 101023 in the Town of Bloomfield.

Pursuant to Section 16-50j-40 of the Regulations of Connecticut State Agencies, "Prior to submitting a petition for a declaratory ruling to the Council, the petitioner shall, where applicable, provide notice to each person other than the petitioner appearing as record as an owner of property which abuts the proposed primary or alternative sites of the proposed facility, each person appearing of record as an owner of the property or properties on which the primary or alternative proposed facility is to be located, and the appropriate municipal officials and government agencies. Proof of such notice shall be submitted with the petition for declaratory ruling."

Therefore, the petition is incomplete at this time. The Council recommends that the petitioner provide proof of service of a copy of the petition for a declaratory ruling on the Town of Windsor, the Town of Bloomfield Inland Wetland and Watercourse Commission, owner of property on which the proposed facility is to be located and owners of parcel nos. 8124 and 101023 in the Town of Bloomfield on or before December 30, 2016. If additional time is needed, please submit a written request for an extension of time prior to December 30, 2016.
