Dear Ladies and Gentlemen:

Pursuant to Section §16-50j-40 of the Connecticut Siting Council's (the "Council") regulations, we are notifying you that The TJX Companies, Inc. ("TJX") filed on December 13, 2016, a petition for declaratory ruling with the Council. The petition will request the Council's approval of the location and construction of a 500 kilowatt Bloom Energy Corporation fuel cell and associated equipment at the TJX Homegoods facility at 1415 Blue Hills Avenue, Bloomfield, Connecticut. Electricity generated by the Facility will be consumed primarily at the Site, and any excess electricity will be exported to the electric grid. The Facility will be fueled by natural gas.

The purpose of the proposed Facility is to replace the average baseload of the building with a renewable energy sourceⁱ and improve reliability of electrical systems and equipment.
