The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) is hereby submitting a response to the Connecticut Siting Council's letter dated January 31, 2017.

The corrections to Petition 1287 - Attachment A are as follows:

- Line List #s 153, 154 and 301 property owner names were missing on the map text; however, on January 25, 2017, Eversource provided notice to these abutting property owners, see Attachment.
- Sheet 10: The property east of Line List #301 is owned by the Town of Wilton. The Town was notified through Eversource's outreach efforts and through the notice of other properties owned by the Town.
- Sheet 7: The property owner of Line List #224 is not an abutter to the project site and should be removed from the list of abutters. The property owner was not notified of the project.
- Sheet 7: The property owner (Nava Gueron) of Line List #225 is the same owner as Line List #228. The property owner was notified of the Project on January 25, 2017.
