RE: PETITION NO. 1207 – Bloom Energy Corporation, as an agent for Wal-mart Stores, Inc., petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, operation and maintenance of a Customer-Side 200-Kilowatt Fuel Cell Facility to be located at Walmart, 450 Providence Road, Brooklyn, Connecticut.

Dear Ms. Shanahan:

The Connecticut Siting Council (Council) received the petition for the above-referenced facility on December 23, 2015.

According to Section 16-50j-39a of the Regulations of Connecticut State Agencies, “no declaratory ruling shall be issued to any person until a complete petition containing all information relevant by the Council has been filed.”

Staff has reviewed this petition for completeness and has identified a deficiency in notice to the Commissioner of the Department of Agriculture, and lack of a clearly labeled abutters’ map that identifies the parcels corresponding to the abutters on the list. Pursuant to Section 16-50j-40 of the Regulations of Connecticut State Agencies, “Prior to submitting a petition for a declaratory ruling to the Council, the petitioner shall, where applicable, provide notice to each person other than the petitioner appearing as record as an owner of property which abuts the proposed primary or alternative sites of the proposed facility, each person appearing of record as an owner of the property or properties on which the primary or alternative proposed facility is to be located, and the appropriate municipal officials and government agencies. Proof of such notice shall be submitted with the petition for declaratory ruling.”

Therefore, the petition is incomplete at this time. The Council recommends that the petitioner provide proof of service of a copy of the petition for a declaratory ruling on the Commissioner of the Department of Agriculture and a clearly labeled abutters’ map that identifies the parcels corresponding to the abutters on the list on or before January 5, 2016.
