**RE: Petition of Walmart, Brooklyn, CT for a Declaratory Ruling for the Location and Construction of a 200-Kilowatt Fuel Cell Customer-Side Distributed Resource at 450 Providence Road, Brooklyn, CT**

Dear Property Owner,

Pursuant to Section 16-50j-40 of the Connecticut Siting Council's (the "Council") regulations, we are notifying you Walmart, Brooklyn, CT intends to file on or shortly after December 16, 2015, a petition for declaratory ruling with the Council. The petition will request the Council's approval of the location and construction of an approximately 20 kilowatt Bloom Energy fuel cell and associated equipment (the "Facility"), located at the site of the Walmart, located at 450 Providence Road, Brooklyn, Connecticut (the "Site"). Electricity generated by the Facility will be consumed primarily at the Site, and any excess electricity will be exported to the electric grid. The Facility will be fueled by natural gas.

The Facility will be located at the rear of the building on an area that is presently paved. The fuel cell is approximately 26'-5" long, 8'-7" wide and 6'-9" high.
