RE: Status Update Request for the following Petition:

PETITION NO. 1208 – Bloom Energy Corporation, as an agent for Wal-mart Stores, Inc., declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, operation and maintenance of a Customer-Side 200-Kilowatt Fuel Cell Facility to be located at the Sam's Club store, 69 Pavillions Drive, Manchester, Connecticut.

Dear Mr. Makin:

Pursuant to Connecticut General Statutes §§ 4-176 and 16-50k, the Connecticut Siting Council (Council) is required to approve by Declaratory Ruling the construction and location of fuel cell facilities unless the Council finds a substantial adverse environmental effect.

To date, the Council is not in receipt of any communication that construction has been completed for the above-referenced facility and hereby requests written notification on the status of this matter no later than June 1, 2019. Please include in your status update if you will not proceed with construction.

Please note that the Council routinely imposes standard conditions when issuing Declaratory Rulings, which may include compliance with Public Act 11-101, An Act Adopting Certain Safety Recommendations of the Thomas Commission or, prior to Petition No. 962, compliance with conditions imposed under the Docket No. NT-2010 Decision and Order for fuel cell petitions, which can be found on our website under the link Decisions/Dockets [<http://www.ct.gov/csc/cwp/view.asp?a=962&q=467870>].

Please be advised that failure to comply with the conditions of any Declaratory Ruling may result in the Council refraining from considering any pending or future matters until full compliance is reached.


If the facility owner/operator has changed, please notify the Council with the contact information for the individual or representative responsible for management and operation of the facility.
