Directions to Site from New Britain

1. Take Route 9 South to Interstate 95 North.
2. Take I-95 North to Exit 87 in Groton (Clarence B. Sharp Memorial Highway or Route 349).
3. Take Exit 87 onto Clarence B. Sharp Memorial Highway (Connecticut Route 349), and proceed to the second traffic light (at intersection with Rainville Avenue).
4. Go straight through the second light. Route 349 becomes Brandegee Avenue. Pass the West Side Middle School on the left. The access lane into Pfizer is on the right.
5. Once in the access lane turn left into the Pfizer Visitor parking entrance. Do not pass through the gates.
6. Park in the Visitor Parking Lot, and walk to the Visitor Center.

Directions to Site from Stonington area

1. Take I-95 South to Exit 87 in Groton (Clarence B. Sharp Memorial Highway or Route 349). Exit 87 is a left-hand exit.
2. Take Exit 87 onto Clarence B. Sharp Memorial Highway (Connecticut Route 349), and proceed to the second traffic light (at intersection with Rainville Avenue).
3. Go straight through the second light. Route 349 becomes Brandegee Avenue. Pass the West Side Middle School on the left. The access lane into Pfizer is on the right.
4. Once in the access lane turn left into the Pfizer Visitor Parking Lot. Do not pass through the gates.
5. Park in the Visitor Parking Lot, and walk to the Visitor Center.
