# Petition 1217 Bloomfield-Windsor Upgrades Project Monthly Construction Progress Report January 2017

#### **OVERHEAD TRANSMISSION LINE**

#### 1777/1779 Line Separation:

In January, transmission line clearing and access road construction were completed in the Bloomfield to Bloomfield Junction area. Construction pads for structures 3107-1, 3108-1, 3109-1 and 3110-1 were completed. The construction pad development for this segment is complete.

All concrete foundations have been completed. Once the concrete cures the contractor will begin to set the new structures

Five of the nine direct-embedded structures have been erected. .

#### 1777/1751 Line Separation:

Clearing, access road work and construction pad installation was completed between structures 3164 and 3155. The foundation for structure 3164-1 is complete.

At Bloomfield Junction, foundations have been completed for structures 10168, 3115, 3115-1B, 3116, 3116-1 and 3164. Direct-embed structures 10168 and 10166 were also erected.

#### 1779 Line Loop into Rood Avenue Substation:

The foundations for structures 20077A and 10143B were completed and structures 20077A and 20076A were erected. The contractor plans to remobilize in early February to erect structures 10143A and 10142B.

#### **SUBSTATIONS**

Work at Bloomfield Substation and North Bloomfield Substation is complete.

At Rood Avenue Substation, foundation work is near completion and electricians have begun installing substation steel within the expansion area. The contractor is also actively working on installing the XLPE cable duct bank. Wiring of relay panels and test devices inside the control enclosure are completed.

#### **MINOR D&M PLAN CHANGES**

No minor changes were made the D&M plan in the month of January 2017.
