Dear Ms. Bachman:

In accordance with Condition 6.vii in the Connecticut Siting Council's (CSC) Decision and Order, dated July 21, 2016, PSEG Power Connecticut LLC (PSEG) is required to obtain City of Bridgeport approval for the Special Inspector providing oversight of the natural gas fuel pipe cleaning scope. PSEG filed the 15 Day Notice with the CSC on November 13, 2018 and the City Fire Marshal approval on November 15, 2018. At that time, the City Building Official indicated to PSEG that he felt that the Fire Marshal approval was sufficient.

Subsequently, based upon the wording of the CSC Condition and a request from Mr. M. Perrone of your office, PSEG solicited additional correspondence from the Building Official. A copy of the email response from the Building Official to William Gerardi (Project Manager – PSEG) is attached as Exhibit 1.

In addition, as previously communicated, Mr. Pat Convery, P.E. of Cornerstone Energy Services is serving as the Special Inspector. His contact information on the submitted resume was incomplete. The full Special Inspector contact information is:
