RE: **PETITION NO. 1218** – PSEG Power Connecticut LLC declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance, and operation of a new 485 megawatt (MW) dual fuel combined-cycle electric generating facility at the existing Bridgeport Harbor Station located at 1 Atlantic Street, Bridgeport, Connecticut. **D&M Plan Revision.**

Dear Mr. Hinchey:

The Connecticut Siting Council (Council) is in receipt of your correspondence received April 12, 2018 regarding the revision to the Phase I and Phase II Development and Management (D&M) Plans for the above-referenced project that were approved by the Council on October 27, 2016 and December 22, 2016, respectively.

Pursuant to Regulations of Connecticut State Agencies §16-50j-62(b), your request for modifications including, but not limited to, minor refinements in structure locations; mechanical and electrical changes associated with code compliance; updates from various suppliers regarding the water and ultra-low sulfur distillate tanks, air cooled condenser and prefabricated buildings; final plant elevations and general arrangements; final site finishing and grading plans; and final underground utility routings on Henry and Russell Street are hereby approved. The modifications will not result in changes to the height or location of the heat recovery steam generator stack or auxiliary boiler stack, limits of disturbance, electric and magnetic fields, off-site impacts, and will not increase the drainage area for stormwater purposes or change stormwater flows.

This approval applies only to the D&M Plan revision received April 12, 2018. Any significant changes to the D&M Plan require advance Council notification and approval.
