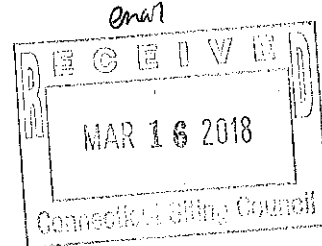

This letter is a follow-up to communication with you regarding the change of ownership of Woods Hill Solar, LLC. As the Council is aware, Woods Hill Solar, LLC, was a subsidiary of Renewable Energy Systems Americas Inc. ("RES Americas"). As indicated on p. 2-1 of the Petition in this matter, RES Americas provides a variety of renewable energy services, and is affiliated with the Sir Robert McAlpine Group, a family-owned construction and engineering firm.

As I indicated to you previously, RES Americas has sold one hundred percent (100%) of its interests in Woods Hill Solar, LLC to Enel Green Power North America Inc. ("Enel"). Enel is part of the Enel Group, which is a multinational energy companies and one of the world's leading integrated electricity and gas operators. The Enel Group works in 37 countries across five continents, with a net installed capacity of almost 84 GW. The Enel Group has approximately 64 million customers around the world, and has a highly diversified portfolio of generation sources, including: hydroelectric, wind, geothermal, solar, thermoelectric, nuclear and other renewable sources of power.


