RE: **PETITION NO. 1224** – Woods Hill Solar, LLC declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed construction, maintenance and operation of a 20 Megawatt AC Solar Photovoltaic Electric Generating facility located at 90 and 101 Woods Hill Road, Pomfret, Connecticut.

Dear Attorney Hoffman:

The Connecticut Siting Council (Council) is in receipt of your request dated October 25, 2017 regarding the temporary change to work hours approved as part of the Development and Management (D&M) Plan for the above-referenced project that was approved by the Council on September 6, 2017.

Pursuant to Regulations of Connecticut State Agencies §16-50j-62(b), your request to work on Sunday, October 29, 2017 and Sunday, November 5, 2017 during daylight hours to perform critical path testing on the site is hereby approved. This work is expected to take approximately eight to nine hours each day. Currently approved work hours are Monday through Saturday, 6:30 a.m. to 7:30 p.m. with no noise generating activities beginning until 7:00 a.m. each day.

This approval applies only to the request for the temporary change to work hours dated October 25, 2017. Any significant changes to the D&M Plan require advance Council notification and approval.

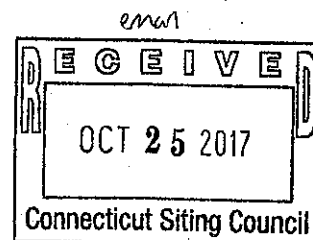


Dear Ms. Bachman:
