Dear Attorney Hoffman:

The Connecticut Siting Council (Council) is in receipt of your request dated April 25, 2018 regarding the temporary change to typical work hours approved as part of the Development and Management (D&M) Plan for the above-referenced project that was approved by the Council on September 6, 2017.

Pursuant to Regulations of Connecticut State Agencies §16-50j-62(b), your request to work on Sunday, April 29, 2018 from 7:00 a.m. to 6:00 p.m. to perform site stabilization work on the site is hereby approved. The Sunday work hours are necessary to perform site stabilization through the installation of erosion control blankets, installation of tackifier and grass seeding and the establishment of swales and mulch berms.

This approval applies only to the request for the temporary change to work hours dated April 25, 2018. Any significant changes to the D&M Plan require advance Council notification and approval.

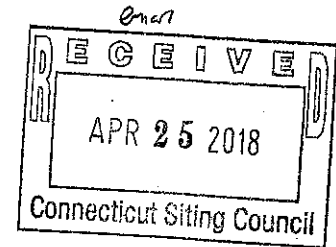

I am writing on behalf of my client, Woods Hill Solar, LLC, in connection with the above-referenced Petition. This letter is a follow-up to prior correspondence to the Council regarding this site. Woods Hill Solar, LLC is writing this letter to request permission to perform environmental work on the site. This work would consist of a team of approximately 25 individuals performing work on the site as follows:

- 20 people for erosion and sediment control work; and
- 5 individuals responsible for management and safety.


