Thank you for your interest and concern in this matter.

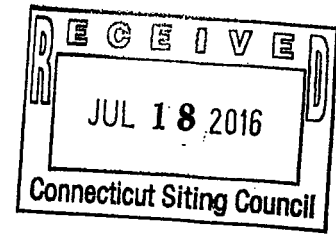

Re: Petition No. 1234 - SolarCity Corporation – Petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the Construction and Operation of a Solar Photovoltaic Electric Facility at 7 Grace Way in North Canaan, Connecticut

Dear Ms. Bachman:

We are writing as our Commission has received a notice from both Robinson and Cole (as representative of SolarCity) and The Connecticut Siting Council that Becton, Dickinson and Company intends to have SolarCity install a solar photovoltaic electric generating facility at 7 Grace Way in North Canaan, CT. In concept, the Commission supports the plan to install the said facility but feels that due to the location of the proposed activity in proximity to Robbins Swamp, the project needs to proceed with diligence to ensure the ecology of said Swamp is not compromised.

An "Existing Conditions Map" supplied to our Commission from SolarCity (via Robinson and Cole) shows that it is the intent to clear approximately 9 acres ± of woodland. To the north of the area proposed for clearing, there are wetlands and vernal pools within approximately 400 feet (scaled). To the west, the proposed clearing will be within 200 feet (scaled) of the FEMA 100-year flood line. Upon review of the Natural Diversity Data Base map for this area, it becomes apparent that the general area in which this activity is proposed supports many rare and endangered species that inhabit Robbins Swamp, the largest (calcareous) inland wetland within the State of Connecticut. It is also important to realize that due to the site's location at the northernmost edge of Robbins Swamp, any activity proposed for this site could have the potential for impacting the entire swamp to the south.

The proposed activity of clearcutting will alter the habitat of nine acres adjacent to Robbins Swamp. A close examination of this area prior to construction of the said solar generating facility and prescribed measures to prevent sedimentation of the swamp during land clearing appears prudent to our Commission.

It is the consensus of our Commission that some form of oversight of this project is essential to ensure the integrity of Robbins Swamp. At minimum, an acknowledged guarantee of oversight by the North Canaan Inland Wetlands Commission to the Siting Council would seem prudent prior to the Siting Council issuing a declaratory ruling that no 'Certificate of Environmental Compatibility and Public Need' is required.

If our Commission can be of further assistance in aiding your decision, we encourage you to contact us at the above address. Robbins Swamp is one of our State's ecological gems and warrants protection.
