This letter is to notify the Connecticut Siting Council (“Council”), pursuant to Regulation of Connecticut State Agencies (“RCSA”) 16-50j-60 to 16-50j-62, of the completion of construction activities and report on monthly progress, in association with Petition 1234, for the construction, maintenance and operation of an approximately 2.8-megawatt solar voltaic electric generating facility located at the Becton, Dickinson & Company, 7 Grace Way, North Canaan, Connecticut.

The project completed construction on March 20th, 2018 and the system was online on March 28th, 2018. The system testing and commissioning were completed on April 30th, 2018. The final total AC megawatts (MW) of the project is 1.98 MW (AC) (2.66 MW (DC)).
