RE: PETITION NO. 1238 - Eversource Energy declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed re-conductoring of 0.6 miles of its existing No. 1779 115-kilovolt (kV) electric transmission line between South Meadow Substation in Hartford and the east side of structure 3001 in East Hartford and for the proposed rebuilding of 4.6 miles of its existing No. 1779 electric transmission line within existing Eversource right of way extending from structure 3001.5 in East Hartford to South Windsor Junction in South Windsor, traversing the municipalities of Hartford, East Hartford, and South Windsor, Connecticut, and related transmission line structure and substation improvements.

Dear Ms. Taylor:

The Connecticut Siting Council (Council) is in receipt of your email correspondence of March 26, 2018 regarding the temporary change to work hours for the above-referenced Project that was approved by the Council on October 27, 2016.

Pursuant to Condition No. 3 of the Council's Decision on October 27, 2016, your request for an extension of construction work hours from 5 AM to 7 AM on March 27, 2018 near Structure 3008 in East Hartford is hereby approved. The additional work hours are necessary as a result of Eversource's coordination with the Connecticut Department of Transportation regarding the foundation work at structure 3008. On March 14, 2018, the Council had approved additional work hours in this area to allow work activities to occur from 7 PM to 5 AM.

This approval applies only to the request for a temporary change to Project work hours in the email correspondence of March 26, 2018. Any significant changes to the project require advance Council notification and approval.


