
Dear Ladies and Gentlemen:

Pursuant to Section 16-50j-40 of the Connecticut Siting Council's (the "Council") regulations, we are notifying you that Frontier Communications Corp. intends to file on or shortly after October 17, 2016, a petition for declaratory ruling with the Council. The petition will request the Council's approval of the location and construction of an approximately 400 kilowatt Bloom Energy Corporation fuel cell facility and associated equipment (the "Facility"), located at the site of the Frontier Communications building at 2 Washington Street, Norwalk, Connecticut (the "Site"). Electricity generated by the Facility will be consumed primarily at the Site, and any excess electricity will be exported to the electric grid. The Facility will be fueled by natural gas.

The proposed placement of the fuel cells is at the rear of the building where existing mechanical equipment are currently located. In total, the proposed facility will be approximately 70 feet long, 4 feet wide, and 7 feet high.
