The Connecticut Siting Council (Council) is in receipt of the email correspondence dated January 26, 2018, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on February 16, 2017.

Pursuant to Condition No. 1 of the Council's Decision on February 16, 2017 and page 3 of the Council staff report, your request to perform work from 9:00 am until 6:00 pm on Sunday, January 28, 2018 at Southington Substation is hereby approved. The Sunday work hours are necessary to support wiring and testing operations within the substation to meet a scheduled outage.


