The Connecticut Siting Council (Council) is in receipt of the email correspondence dated June 21, 2018, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on February 16, 2017.

Pursuant to Condition No. 1 of the Council's Decision on February 16, 2017, your request to perform work until 9:00 p.m. on June 21 through 23, 2018 and from 7:00 a.m. to 6:00 p.m. on Sunday, June 24, 2018 at Southington Substation is hereby approved. The extended work hours are necessary due to an unexpected change in switching orders from the Connecticut Valley Electric Exchange (CONVEX) which resulted in a delay during the scheduled outage. Eversource will perform quiet work within the fenced substation.


## Dear Ms. Bachman:
