The Connecticut Siting Council (Council) is in receipt of the email correspondence dated May 3, 2017, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on February 16, 2017.

Pursuant to Condition No. 1 of the Council's Decision on February 16, 2017 and page 3 of the Council staff report, your request to perform work until 8:00 pm on May 3-5, 2017 at Southington Substation is hereby approved. The extended work hours (beyond the currently approved 7:00 a.m. to 7:00 p.m. Monday through Saturday work window) are necessary to support testing operations within the control house.

This approval applies only to the request for changes to work hours dated May 3, 2017. Any significant changes to the project require advance Council notification and approval.


