The Connecticut Siting Council (Council) is in receipt of the email correspondence dated December 7, 2017, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on February 16, 2017.

Pursuant to Condition No. 1 of the Council's Decision on February 16, 2017, your request to perform work from 7:00 p.m. to 9:00 p.m. on December 8, 2017 at Southington Substation is hereby approved. The extended work hours (beyond the currently approved 7:00 a.m. to 7:00 p.m. Monday through Saturday work window) are necessary to support live work within the new control house and distribution shed.

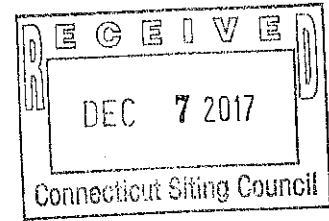
