The Connecticut Siting Council (Council) is in receipt of the email correspondence dated February 21, 2018, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on February 16, 2017.

Pursuant to Condition No. 1 of the Council's Decision on February 16, 2017, your request to perform work from 9:00 pm until 11:00 pm on February 21 through 23, 2018 at Southington Substation is hereby approved. The extended work hours are necessary due to an unexpected change in switching orders which resulted in a delay during the scheduled outage. Work will be performed inside the control house.

This approval applies only to the request for changes to work hours dated February 21, 2018. Any significant changes to the project require advance Council notification and approval.


