RE: **PETITION NO. 1289** - Eversource Energy petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed modifications to the existing Green Hill Substation located at 775 Green Hill Road, Madison, Connecticut.

Dear Ms. Shanley:


The Connecticut Siting Council (Council) is in receipt of your email correspondence dated September 22, 2017, regarding temporary changes to work hours for the above-referenced project that was approved by the Council on March 30, 2017.

Pursuant to Condition No. 1 of the Council's Decision of March 30, 2017, your request to perform work from 8 AM to 6 PM on Sundays from September 24, 2017 through November 19, 2017 is hereby approved. The work is necessary to complete substation construction tasks within outage windows and to recover work time lost due to equipment delivery delays related to recent hurricanes. The majority of Sunday work will occur within the substation control house using a minimal work crew except for normal substation construction activities scheduled for September 24, 2017.

This approval applies only to the request for changes to work hours dated September 22, 2017. Any significant changes to the project require advance Council notification and approval.

Eversource is requesting Council Staff approval of work hours (8 a.m. to 6 p.m.) on Sundays from September 24 through November 19, 2017 at Green Hill Substation. The reason for the request is to meet schedule outage windows, but also mitigate delays in major equipment delivery resulting from the recent hurricanes. The majority work would be quiet electrical testing inside the control house with minimal crew on site, except for Sunday, September 24, which would involve normal construction at the substation.

Municipal officials have been notified and the abutters will be contacted about this work in advance of work activities.
