

Dear Chairman Stein and Commissioners:

I write this letter to express the Town of East Windsor's support for Lodestar Energy's proposed solar photovoltaic facility at 84 Wapping Road, East Windsor, CT (the "Project"). The Town of East Windsor shares the state and regional concerns regarding the significant electrical generation capacity shortage projected for Connecticut and therefore believes that this is the right place for the project at the right time.

Representatives of Lodestar Energy have met on a number of occasions with Town staff and other organizations, including appearances before the East Windsor Inland Wetland Watercourse Agency, the East Windsor Planning and Zoning Commission and the East Windsor First Selectman's Office.

Lodestar Energy consulted the East Windsor Conservation Commission and other relevant agencies to evaluate the potential environmental and visual impacts to nearby residences. In addition to the completion of a comprehensive Phase I Environmental Site Assessment, Lodestar Energy engaged third-party environmental consultants to evaluate the potential for environmental impacts associated with the Project. Utilizing an array of resources, this Project avoids, reduces, and mitigates potential environmental and visual impacts.

Therefore, we are confident that the Project will be of great benefit to the Town of East Windsor.
