I am writing this letter to confirm prior correspondence in this Petition, dated July 23, 2018, concerning the transfer of the Petitioner, DWW Solar II, LLC, to DESRI Tobacco Valley Acquisition, L.L.C. As noted in that correspondence, DESRI Tobacco Valley Acquisition, L.L.C. is under common control with DWW Solar Holdings, LLC, the prior owner of the Petitioner. This transfer was effective as of July 9, 2018.

This transfer is anticipated to have no material impact on the project that is the subject of this Petition or on DWW Solar II, LLC. As the Council is aware, DWW Solar II, LLC has been and continues to be compliant with all of the terms of the Council's December 21, 2017 Decision and Order, including but not limited to, the payments of fees and assessments as required by the Decision and Order pursuant to Conn. Gen. Stat. § 16-50v. This letter will confirm that both DWW Solar II, LLC and DESRI Tobacco Valley Acquisition, L.L.C. will comply with the terms, limitations and conditions contained in the Council's December 21, 2017 Decision and Order, including, but not limited to, the payment of fees and assessments as required by the Decision and Order and/or Conn. Gen. Stat. § 16-50v.
