Re: Petition number 1316. Comments regarding petition of Cellco Partnership d/b/a Verizon Wireless for a Declaratory Ruling on the need to obtain a Siting Council certificate for the installation of a small cell telecommunications facility at 1245 Farmington Avenue, West Hartford, Connecticut dated July 19, 2017

Dear Chairman:

I recently received a notice letter stating that Cellco Partnership intended to file a petition for a declaratory ruling and a copy of the intended petition for declaratory ruling from Attorney Kenneth C. Baldwin with the law firm of Robinson and Cole, 280 Trumbull Street, Hartford, Connecticut 06103-3597.

As an adjoining property owner established by the petition, I submitted my petition to be made a party to the proceedings for a final decision on the petition.

Section 16-50k of the Connecticut General Statutes requires the petitioner to establish "environmental compatibility and public need" for issuance of a certificate. Cellco has not demonstrated a public need for the facility in its petition.

Environmentally, the existing utility poles and distribution wires on Farmington Avenue feeding the proposed facility are an eyesore – a rat's nest - when viewed from my property. If feasible, the wires should be buried underground.
