RE: PETITION NO. 1337 - The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed Stepstone to Green Hill Substation Upgrade Project that includes replacement of approximately 5.6 miles of its existing No. 1508 115-kilovolt (kV) electric transmission line structures within existing Eversource electric transmission line right of way between Stepstone Substation located at 50 Stepstone Road, Guilford, Connecticut and Green Hill Substation located at 775 Green Hill Road, Madison, Connecticut, and related electric transmission line structure improvements.

Dear Ms. Taylor:

The Connecticut Siting Council (Council) is in receipt of the email correspondence of April 9, 2018 regarding minor project changes to the above-referenced project that was approved by the Council on February 1, 2018.

Pursuant to Condition No. 2 of the Council's Decision on February 1, 2018, your request to change the pull pad on Eversource-owned property near Structure 5902 from gravel to temporary upland matting as it is more suitable for this location; the pull pad on Guilford Land Trust-owned property near Structure 5942 from temporary upland matting to gravel due to challenging topography in the area; and the work pad for Structure 5960 from gravel to matting due to a request from the underlying property owner, is hereby hereby approved. The location and size of the pads would remain the same.

This approval applies only to the minor project changes described in your email of April 9, 2018. Any significant changes to the project require advance Council notification and approval.



Eversource is requesting approval from Council staff to modify two pull pads and one work pad, all located in upland areas. The pull pad near Structure 5902 is on Eversource property and would be changed from gravel to temporary upland matting, which is more suitable for construction at this location. The pull pad near Structure 5942, located within the Guilford Land Trust area, is proposed to be changed from temporary upland matting to temporary gravel due to the challenging topography of the area. The Guilford Land Trust has agreed to this modification. In addition, the property owner requested to change the work pad for structure 5960 from gravel to matting. The size and location of the pads will remain the same.

The municipal officials of Guilford and Madison have been notified.
