

Re: Pawcatuck Solar Center, LLC – Petition for Declaratory Ruling for the Construction, Operation and Maintenance of a Solar Photovoltaic Electric Generating Facility off Ella Wheeler Road, North Stonington, Connecticut

Dear «Salutation»:

Pawcatuck Solar Center, LLC ("Pawcatuck Solar"), named for the nearby Pawcatuck River, intends to file a Petition for Declaratory Ruling ("Petition") with the Connecticut Siting Council ("Council") on or about May 23, 2018, seeking approval of the construction, operation and maintenance of a fifteen (15) megawatt (MW) AC solar generating facility, including all associated equipment and related site improvements (the "Project"). The Project would be located on two (2) parcels, totally 278 acres and a portion of two (2) parcels totaling approximately 75 acres, off Ella Wheeler Road in North Stonington, Connecticut. The site is generally bounded by Pendleton Hill Road, Interstate 95, Boombridge Road and the Pawcatuck River (the "Property").

The Project would consist of the installation of photovoltaic panels, centralized inverters and transformers, electrical lines, a step-up transformer, a station controller, a perimeter fence, and access roads. For additional detail regarding the location of the Property and the layout of site improvements, please see the attached project plans.

Pursuant to the provisions of Connecticut General Statutes § 16-50g et seq., the location of certain Project features may change as this Petition proceeds through the Council's regulatory review process.
